A. Definition

Voluntary Disclosure Program / VDP (PPSWP) is a voluntary net asset disclosure program for assets obtained by taxpayers, provided that the Director General of Taxes has not found data and/or information regarding this matter.

PPSWP I

The program for disclosing net assets obtained by corporate taxpayers and individual taxpayers from January 1, 1985 to December 31, 2015.

PPSWP II

The program for disclosing net assets obtained by corporate taxpayers and individual taxpayers from January 1, 2016 to December 31, 2020.

B. PPWSP Period

This program only lasts for 6 (six) months, starting January 1, 2022 to June 30, 2022.

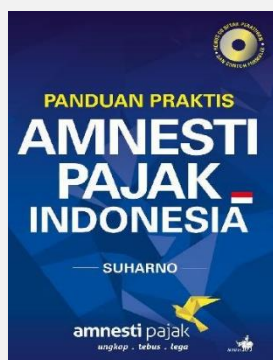

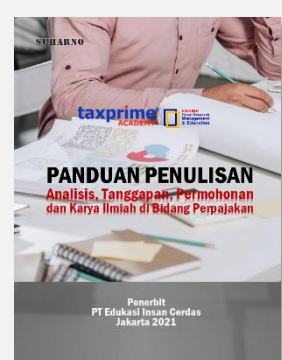
